Hadii aad saxeexo Amaahda Daynta Ilmaha, waxay saamayn doontaa kabka kale ee dawlada (sida SSI, SNAP, TANF, ama WIC)?

Maya. Helitaanka lacagbixinta Daynta Cashurta Ilmaha looma tixgalin karo dakhli qoysnaba. Sidaa darteed, ma badali doonto lacagta aad ku hesho kabka kale ee Federaalka. Kabkan Dawlada Fadaraalku bixiso waxa kujira caymiska shaqo la'aanta, Caymiska danyarta, SNAP, SSI, SSDI, TANF, WIC, Section 8, ama guryaha dadwaynaha.



Caawimooyinka Guud waxa saamayn kara! Haddii aad ku jirto Caawimada Guud, waad dooran kartaa lacag bixinta bil kasta sabab kasta ha noqotee. Si aad u doorato lacagaha billaha ah, ama aad iska diiwaangeliso, waxaad aadi kartaa Goobta Amaahda Canshuurta Ilmaha ee IRS. Halkee ayay IRS kusoo diraysaa lacagtayda?

IRS waxay kuu soo diri doontaa lacagahaaga iyagoo toos ugu shubi doona akoonka bangiga ee ay ku jira. Haddii aysan kuu haynin maclumaadka akoonka bangiga, hubin ayaa lagu soo diri doonaa.

Ka waran haddii aanan lahayn lambarada soshiyal sakuyuuratiga lakin caruurtaydu leedahay?

Immisa ayaan ka heli doonaa lacagaha Gunada Canshuurta Ilmaha?

Inta badan qoysasku waxay heli doonaan xadi dhamaystiran: \$3,600 oo loogu talagalay ilmo kasta oo ka yar da'da 6 iyo \$3,000 ilmo kasta oo da'diisu tahay 6 illaa 17. Si ay dhaqso ugu helaan qoysasku, IRS waxay u diri doontaa qoysaska kalabadh nuskooda 2021 Gunada Canshuurta Ilmaha oo ah lacag bille ah oo ah \$300 cunug kasta oo da'diisu ka yar tahay 6 iyo \$250 ilmihi u dhexeeya 6 iyo 17 sano.

Xadigan wuu kukala duwanan karaa dakhliga. Dadkan waxay u qalmaan in la siiyo Gunada Cashuurta Ilmaha oo dhamaystiran.

- Lammaanayaasha isqaba ee dakhligoodu ka hooseeyo \$ 150,000
- Qoysaska leh waalid keli ah (sidoo kale loo yaqaan Madaxa Qoyska) oo leh dakhli ka yar \$112,500
- Qof kasta oo kale lehna dakhli kayar \$75,000

Dadkani waxay u qalmi doonaan ugu yaraan \$2,000 ee Gunada Canshuurta Carruruuta, taas oo noqonaysa \$166 ilmihiba kasta bil kasta:

- Lammaanayaasha isqaba ee dakhligoodu ka hooseeyo \$400,000
- Qoysaska leh waalid keli ah (sidoo kale loo yaqaan Madaxa Qoyska) oo leh dakhli ka yar \$200.000
- Qof kasta oo dakhligiisu ka hooseeyo \$200,000

Qoysaska xitaa dakhligoodu sarreeyo waxaa laga yaabaa inay helaan qaddar yar ama aan haba yaraatee wax deyn ah lahayn.
