- Under \$50,000 (individual filer)
- Under \$75,000 (head of household)
- Under \$100,000 (married filing jointly)

There is no minimum earnings requirement. So even if you don't usually file taxes, you can still get this money, you just need to file a state tax return using your SSN or ITIN. **The deadline to apply is October 15, 2026.**
